# PRIVACY POLICY

# Purpose of Policy

Transcend Medical respects the privacy of its customers and other visitors to this website. Thus, we created this Privacy Policy to inform you about our information practices. This Privacy Policy applies only to this website and not to any other websites that you may be able to access from this website.

## What information do we collect?

- We collect information from you when you submit information on this website, send an email from this website, place an order, enter a contest or sweepstakes, respond to a survey or communication, submit an inquiry such as email, or participate in another website function or feature.
- We collect personal information that you provide if you establish an account on this website, such as your first and last name, email address, shipping address, and a password. When you create an online account with Transcend Medical, you can choose to save your billing and shipping information. When you submit an inquiry or contact our Customer Service department, we may ask you for your name, email address, mailing address, phone number, credit card information, or other information. You may, however, visit our website without providing such information.
- When you make a purchase from Transcend Medical, we collect your name and payment method information, such as credit card and billing information. We collect this information in order to bill you for your purchase. We also collect information that allows us to ship your order. This includes the name, address, and phone number of the intended recipient(s). If you make a purchase through your online account, we also maintain a record of your purchases online.
- Like many websites, we use "cookies" or other technology to enhance your experience and gather information about visitors and visits to our websites. Please refer to the "Do we use 'cookies'?" section below for information about cookies and related technology and how we use them.

## How do we use your information?

We may use the information we collect about you in ways described elsewhere in this Privacy Policy and in the following ways:

- To personalize your website experience and to allow us to deliver the type of content and product offerings in which you may be most interested.
- To allow us to better serve you in responding to your customer service requests.
- To register you as a user of this website.
- To quickly process your transactions and communicate with you regarding your order.
- To confirm your orders.
- To deliver the products and services that you purchase or rent online.
- To prevent fraud and bill you for your purchases.
- To administer a contest, promotion, survey or other website feature.
- To comply with valid legal procedures, requirements, regulations or statutes.

When we refer to your information, information about you or personal information, we mean information that we collect and store in a way that allows us to relate it to you personally or to your family, such as your name, email address, mailing or billing address, and phone number. This Privacy Policy applies only to that type of information. We may freely use, disclose or sell information that is not specifically associated with you personally or your family (such as statistics or aggregate information about our customers or website visitors).

# How do we protect visitor and customer information?

We implement a variety of security measures to protect your personal information. Your personal information is contained behind secured networks. Persons who are authorized to access your personal information are required to keep the information confidential to the extent stated in this Privacy Policy. We use a technology called Secure Sockets Layer (SSL). If your browser is capable of SSL (and most are), your personal information and credit card or debit card information will be automatically encrypted or encoded before it is sent over the Internet. However, no method of transmission over the Internet or electronic storage is 100% secure.

Therefore, while we strive to use commercially reasonable means to protect your personal information, we cannot guarantee its absolute security.

Your personal information is also protected by the password that you created if you signed up for an online account with Transcend Medical (or another password you chose after changing a previous password). Please keep this password confidential. The confidentiality of your password is your responsibility. You may log onto this website at any time to change your password.

#### Do we use "cookies"?

Yes. Cookies are small files that a website or its service provider transfers to your computer's hard drive through your Web browser (unless you set your browser to reject cookies) that enables the website's or service provider's systems to recognize your browser and capture and store certain information. They may be used to help us understand your preferences based on previous or current website activity, which may enable us to provide you with improved services. We also may use cookies to help us compile aggregate data about website traffic and website interaction so that we can offer better website experiences and tools in the future.

We may contract with third-party service providers to assist us in better understanding our website visitors. These service providers are not permitted to use the information collected on our behalf except to help us conduct and improve our business.

Our servers automatically recognize visitors' domain names and IP addresses (the number assigned to computers on the Internet). No personal information about you is typically revealed in this process. This website may also use other technology to collect information from time to time.

#### Do we disclose the information we collect to outside parties?
